- 4. Conveyance and legal vetting of various tender documents, agreements, deeds, bonds, memorandums, pledges, other legal documents, preparing Standard Operating Procedure(s), guidelines, and standard formats for such legal documents, also give advice on MOU's, Contracts, tenders etc.
